Ohio Minimum Wage Increase

Ohio's minimum wage has increased 30 cents to \$7.70 an hour. This increase is part of a constitutional amendment voters approved in 2006, which says the minimum wage will increase each year at the rate of inflation.

The \$7.70 applies to workers 16 and older who do not get tips. The wage for tipped employees will be \$3.85, an increase of 15 cents, but their total pay cannot be less than \$7.70 an hour

The wage will be required to be paid by employers who gross more than \$283,000 annually, up from the current \$271,000. For smaller companies, and for 14- and 15-year-old workers, the minimum wage matches the federal rate, which is \$7.25 per hour currently.
