The director of the Federal Housing Finance Agency, the regulator of Fannie Mae and Freddie Mac, has announced that Fannie Mae and Freddie Mac, whose participation in the Home Affordable Modification Program (HAMP) and Home Affordable Refinance Program (HARP) was scheduled to end this year, will extend their participation in HAMP and HARP through December 2016. The director indicated that Fannie's and Freddie's participation in HAMP would not be extended beyond 2016 and he did not expect that HARP would be extended for Fannie and Freddie beyond 2016.
