Cursing on a Traffic Ticket is Constitutionally Protected Speech

In 2012, William Barboza was given a speeding ticket in Liberty, New York. On the payment form, he crossed out the town name "Liberty" and wrote in "Tyranny," and then wrote a vulgar sentence. A local justice informed Mr. Barboza that his payment had been rejected and ordered him to appear in court. In court, the local justice lectured Mr. Barboza over his use of obscene language and had him arrested on a charge of aggravated harassment, handcuffed, and held for a short period of time before \$200 bail was posted.

A year later, the charge was dismissed. Thereafter, represented by the New York Civil Liberties Union, Mr. Barboza sued the town of Liberty, a prosecutor and two police officers in U.S. District Court for violation of his constitutional rights. In a ruling in September, U.S. District Judge Cathy Seibel wrote, "though crude and offensive to some, the writing did not convey an imminent threat and was made in the context of complaining about government activity," which is not a violation of the law and is protected speech under the First Amendment. The judge also noted 62 other aggravated harassment arrests between 2003 and 2009, which occurred "because of the use of vulgar words in what may be perceived as a threatening context" and ordered the village to stand trial or explore a settlement on allegations that it failed to properly train police officers regarding the First Amendment.
