WELCOME, NANCY K. KRUEGER

NEW NOTARY REQUIREMENTS EFFECTIVE SEPTEMBER 20

Currently, Ohio's requirements to become a notary public vary by county (except for attorneys, who have a lifetime commission). For persons other than attorneys applying to become a notary public, on or after September 20, 2019, the requirements will include passing a criminal background check, required coursework and passing an exam, all administered through the Ohio Secretary of State. The Secretary of State is in the process of adopting rules with respect to the standards and curriculum for these courses and the entities that offer them. The Secretary of State can charge an application fee of up to \$150 and the notary commission is good for five years.

If you are a current notary public, your commission will still be valid until it expires; however, upon expiration, you will be required to undergo a criminal background check and pay a fee not to exceed \$60. If you fail to renew your notary commission, you must reapply and meet all the new requirements, including passing an examination. Attorneys are exempt from these requirements.

In addition, this new legislation will allow electronic notarization in which the notarization would be conducted via live two-way audio-video connection rather than in person. This type of notarization will require notaries, including attorneys, to hold additional authorization, participate in continuing educational classes and have specific types of audio-visual equipment and software. Unlike with regular notarization, notaries who do electronic notarizations will be required to maintain and retain a log that identifies not only the affiant (the person who is signing the document that needs notarized) but also the title or description of each document electronically notarized (at a real estate or real estate financing closing the buyer/borrower may well sign up to a dozen documents that are notarized, each of which will have to be separately listed in the log). This legislation will impose stringent criteria on using this method to notarize documents. We do not believe that, at least in the short term, many notaries will offer electronic notarization due to the extra training required, the cost of the equipment and the required log. We are not sure that electronic notarization will be embraced by those who need their signature notarized as they must go to a location that has the necessary communication equipment rather than just going to a bank or other institution that has a notary licensed in that state.
