2024-2025 Budget Ushers in Changes to Ohio's Tax Laws

On July 3, 2023, Governor Mike DeWine signed Ohio House Bill 33 ("HB 33"), Ohio's 2024-2025 biennial budget legislation, into law. The nearly \$200 billion budget is packed with changes to laws affecting all Ohioans. Assuming our readers would not want to digest a comprehensive summary of all <u>9,198 pages</u> of HB 33, we will first focus on a topic that is said to be one of life's certainties: taxes. Without further ado, below are some highlights of various changes to Ohio's tax laws.

Ohio Income Tax Cuts

HB 33 phases down the income tax rates applicable to nonbusiness income over the next two years. For the 2023 taxable year, the bill reduces the number of brackets from four to three, by consolidating the two lowest tax brackets, and reduces the rates of the lowest and highest tax brackets. Beginning with the 2024 taxable year, the bill consolidates the remaining three brackets into two, and further reduces the highest tax rate. Starting in 2024, Ohioans earning less than \$26,050 annually will pay no state income taxes. Those earning between \$26,050 and \$100,000 will now pay a marginal tax rate of 2.75%, and those earning above \$100,000 will pay a marginal tax rate of 3.5%.

Commercial Activity Tax

Since 2005, businesses operating in Ohio - including retailers, service providers, manufacturers, and most other types of businesses - have been subject to the commercial activity tax ("CAT"). The Ohio Department of Taxation ("ODT") refers to CAT as "an annual tax on the privilege of conducting business activities in Ohio."

HB 33 implements the first major changes to CAT since its inception. Currently, a tiered minimum tax is imposed on all businesses with taxable gross receipts of \$150,000 or more. Additionally, the tax is imposed at a rate of 2.6 mills (0.26%) on taxable gross receipts that exceed \$1 million. In future years, Ohio will no longer impose the annual minimum tax, and beginning in 2024, the taxable gross receipt exemptions will be increased to \$3 million and \$6 million in 2025. An estimated 90% of taxpayers could be excused from future CAT liability.

Governor DeWine's line-item veto removed language that would have defined "excluded persons" as those who do not exceed the exclusion amount, instead of those with not more than \$150,000 of taxable gross receipts. In other words, businesses with over \$150,000 of taxable gross receipts are still, as of now, required to register with ODT even if they are exempt from paying CAT. *Check with your accountant for information on how these changes to CAT might affect your business in the future.*

Other Ohio Tax Law Changes

- Effective October 1, 2023, certain baby-related items will be exempt from sales tax, including diapers, wipes, skin creams/ointments, car seats, booster seats, cribs, and strollers designed for newborns to 36 months old.
- As of January 1, 2023, sports gaming (betting) became legal through licensed sports gaming proprietors, such as online sportsbooks and brick-and-mortar establishments. HB 33 increased the sports gaming tax rate paid by these sports gaming proprietors to the state from 10% to 20%, effective July 1, 2023.
- Beginning in 2024, Ohio will encourage home ownership by allowing a tax deduction for contributions made to a home ownership savings account of up to \$5,000 for single filers and \$10,000 for joint filers. There is a maximum lifetime contribution of \$25,000.
- Beginning January 1, 2024, taxpayers under the age of 18 will no longer be required to pay municipal income tax.
